IV. MDE REPORT: Hue Nguyen, Assistant Commissioner of Education

Hue added a brief addendum to Janet Mohr's update of the Legislative Study Group on Educator Licensing. There will be three proposals to present this week. Only stakeholders spoke at the last hearing, but MDE and BOT will be speaking at the next meeting.

Report on ESSA – focused on accountability, assessment, educator quality, English learners, and school improvement. Many recommendations, such as additional support to school districts, but there is no additional money targeted to this proposal.

All are invited to be a part of the committee working on the ESSA project. More people are still needed if there is more interest. Moving forward with what is achievable. Additional funding needed to complete work has put some things on hold for the moment. The teacher workforce got extra funding, but not the Regional Centers of Excellence or the World's Best Workforce.

A. Licensing Committee

DEB HENTON MOVED to deny a request for K-12 Principal Variance by Minneapolis Public Schools, Special School District #1, for Sherene Judeh. **NANCY ANTOINE SECOND.**Discussion: Ms. Judeh was hired as principal of FAIR School, Minneapolis Public Schools, for the 2016/2017 school year. Ms. Judeh applied for a MN K-12 Principal's license. Upon review of her application additional information was requested about *Reach Institute for School Leadership* where she earned a *Master of Education in Instructional Leadership* and her leadership experience at the *Lighthouse Community Charter School* in California.

Reach Institute does not hold accreditation status with WASC Senior College and University Commission. They are a Candidate for accreditation. Due to their accreditation status, Ms.

Judeh's MA degree is not recognized in Minnesota and her MA degree does not comply with MN Rule 3512.0200.

At their September 14, 2016, meeting, the Professional Development Committee of the Board of School Administrators reviewed the accreditation status of *Reach Institute* and recommended Ms. Judeh contact a MN licensure preparation program. Ms. Judeh intends to enroll at the University of MN to complete an MA degree and K-12 Principal licensure program. She is expected to complete program requirements in 2018. (Yes: *Antoine, Hartung, Henton, Kapler, Mackbee, Meyer, Sundin – Recused: Asberry, Naidicz*) **MOTION CARRIED.**
